## NOMINATIONS AND ELECTIONS Chaired by Lynn Flahive

Lynn and her committee submitted a slate of candidates for the 2011 election. Candidates for President were **Melanie McDonald** and **Bess Sirmon Fjordbak;** candidates for Public Information and Marketing were **Michelle Mendietta** and **Katie Stoneman**; and candidates for Vice President for Professional Services were **Gina Glover** and **Ellen Kester**. The TSHA Executive Board (EB) welcomes Melanie, Katie, and Gina to the board and looks forward to their leadership and contributions to TSHA.

## PUBLIC SCHOOL SLP VACANCIES COMMITTEE Chaired by Cherry Wright

The TSHA/TCASE Joint Committee met three times in Austin with representatives from TSHA, the State Board of Examiners for Speech-Language Pathology and Audiology, and the Texas Council of Administrators in Special Education (TCASE). The Joint Committee, at the request of the Texas Education Agency (TEA), created a document for TEA's consideration with recommendations regarding frequency and duration of services. A number of resources were provided to TSHA members via the web, *Communicologist*, and at the annual convention. The task force is continuing to work with TEA for additional clarification.

Cherry Wright was instrumental in securing a \$500 grant for ASHA to develop SLP-A Training Modules. Work has begun on this important endeavor with the goal to offer the training to both SLP-As and supervisors using online technology. Members of the Development Committee held a conference



call and included members of the ESC Network (Karyn Kilroy, Reg.10 ESC; Paula Chance, Reg. 20 ESC; and Martha Elder, Reg. 15 ESC), university representatives Sherry Sancibrian and Lynn Flahive, and Cherry Wright. Paula will be attending the ASHA Schools Conference in the summer, and JoAnn Wiechmann and Judy Rudebusch will be participating in a special ASHA meeting regarding assistants in the summer. They will report their findings to the committee.

#### PUBLICATIONS BOARD Chaired by Donise Pearson

The Publications Board, in conjunction with the state office, reviewed, edited, and approved hundreds of items for TSHA in the form of newsletters, brochures, booklets, posters, email blasts, press releases, flyers, advertisements, and website postings. Accurate dissemination of information to TSHA members in a timely manner continued to be a priority.

Ann Higdon and Martha McGlothlin served as alternating editors of the *Communicologist*, which was published on time each issue. Julie Noel was added as a member-at-large to the Publications Board and agreed to chair the Publications Board for the next two years. Kathy Clapsaddle oversaw a total redesign of the TSHA website in her capacity as TSHA website editor. President-Elect April Smith served as the Policy and Procedure Manual editor. President Denise Barringer served as an ex-officio member.



At the recommendations of the Publications Board, the Executive Board voted to hire a Publications Editor and Publications Designer. The production of the *Communicologist* will be outsourced. Each issue will be a four-color magazine format displaying a new header. Multiple recommendations were sent forth to the Executive Board for approval, such as moving to an electronic newsletter, adding an electronic bulletin called "TSHA Talk," restructuring the Publications Board to include at least one associate editor for every editor plus other members, and coordinating advertisement initiatives across all publications. Fee increases for advertising opportunities were also requested.

### CONTINUATION OF GUIDANCE (COG) TASK FORCE Co-chaired by Judy Erwin and Becky Gonzalez

The COG Task Force moved toward accomplishing their goal of easily accessible training in eligibility procedures for all SLPs in Texas. In collaboration with the Eligibility Operations (EO) task force, they completed voiceover PowerPoint training modules available to members at no cost and at low cost to non-members. The training was made accessible on Educational Service Center (ESC) websites.

This task force intends to complete the remaining modules (Language, Language with Mental Retardation/Autism, and Language in Culturally and Linguistically Diverse Populations) by the end of the summer. Once all modules are completed, the COG will shift its focus to updating materials and developing strategies to determine the efficacy of the

procedures.

## ELIGIBILITY GUIDELINES/TRAINING TASK FORCE Co-chaired by Judy Rudebusch and Kathy Clapsaddle

The EO Task Force accomplished their goal to facilitate development of online eligibility training. They also actively coordinated with TEA (Texas Education Agency) to develop strategies to monitor efficiency of the training process and collect data concerning districts found to be over- or underidentifying Speech Impaired (SI) students. A subcommittee was formed to develop a technical assistance packet for Education Service Center staff to use when working with identified districts.

## EVIDENCE-BASED PRACTICE (EVP) TASK FORCE Co-chaired by Jenny Katz and Jamie Thomas

The EVP Task Force produced three articles for the *Communicologist* this year featuring TSHA members engaged in action research. The first, written by **Ellen Dupree**, discussed applications of the iPad as a therapy tool. The second and third provided results of research on narrative development completed by **Christina Chen** and **Rebecca Yates** with feedback and comments by **Christine Dollaghan**, a noted researcher in the area. The task force will be planning additional articles next year to provide members with information that will enhance their understanding and implementation of the principles involved in evidence-based practice.

## REGIONAL SEMINAR GRANTS COMMITTEE Chaired by Melissa Whitaker

The purpose of the Regional Seminar Grants is to allow local associations, National Student Speech Language Hearing Association (NSSLHA) chapters, or other nonprofit groups to defray costs incurred in providing regionally advertised seminars or workshops for speech-language pathologists and/or audiologists. The application for the regional seminar grants was again online to make the procedure easier and more efficient for the applicants. Melissa and her committee followed a criterion rating form to rate each individual program. Five grants of \$1,000 were awarded this year and were announced in the *Communicologist* and at the TSHA Annual Business Meeting held during the annual convention.

#### TSHA SUMMER SYMPOSIUM COMMITTEE Co-chaired by Lynn Flahive and Robyn Martin

TSHA continued its tradition with three fun-filled days of educational and cultural discovery at the TSHA Summer Symposium in Santa Fe, New Mexico. **Patricia Prelock, PhD**, presented on autism spectrum disorders (ASD). This continuing education opportunity provided 64 attendees a small group







setting to learn about communication assessment and treatment of clients with ASD. TSHA looks forward to another successful TSHA Summer Symposium in 2012.



## TSHA CONTINUING EDUCATION APPROVAL

Tammy also ensured that all CE hours were transferred onto the TSHA CE registry, which is free to all TSHA members. Additionally, Tammy assisted with the online CE submission process for the 2011 convention.

## ASHA CONTINUING EDUCATION PROCESSOR Loretta Lee

Loretta processed ASHA CE applications as well as all the TSHA Annual Convention ASHA hours. All convention hours were approved this year for ASHA credit. She also helped to ensure that all CE processes were in compliance with ASHA standards.

## BESS SIRMON FJORDBAK★ VICE PRESIDENT FOR SOCIAL & GOVERNMENTAL POLICY

The fiscal year 2010-2011 was a very productive time for the committees and task forces under the



Vice President for Social and Governmental Policy. For the past several years, the focus has been on Sunset Review, with the coordinated efforts of many volunteers dedicated to developing this agenda and disseminating this information. These well-laid plans have come to fruition in the past 12 months. In November 2010, the Texas Legislature's Sunset Commission met, and TSHA's Legislative Team provided testimony that focused on the need for continuation of the State Board of Examiners for Speech-Language Pathology and Audiology.

When the 82nd session of the Texas Legislature began in January, **Senator Robert Nichols** introduced a bill (SB 662) that TSHA supported, which would do exactly that. The TSHA Legislative Leadership team again provided testimony at House and Senate hearings, and the bill passed through both chambers. This bill was signed by **Governor Rick Perry** on June 17, continuing licensure for the profes-

sions of speech-language pathology and audiology for another six years. Passage of this bill represents a significant success for TSHA and the professions.

#### Other pieces of legislation of interest to TSHA were introduced during this session:

• SB 613 was originally introduced on behalf of the Texas Academy of Audiology (TAA). TSHA worked with the staff of bill sponsor **Senator Jose Rodriguez** and leadership of TAA to refine substi-

tute language that addressed doctoral level education for audiologists and accreditation issues for the graduate programs in Texas that would be recognized by the U.S. Department of Education. This bill passed the House and Senate and is on the Governor's desk, awaiting his signature.

• **HB 653** was the current version of student loan repayment, again introduced by **Rep. Wayne Christian**, who has previously supported TSHA's legislative efforts. The bill was referred to the House Higher Education Committee but did not get scheduled for a hearing and died in committee.

• SB 293 related to telehealth and telemedicine services to be provided to certain Medicaid recipients. This bill was somewhat controversial and required a conference committee to reach an agreement. It eventually passed both chambers and has been sent to the Governor for his signature.

• **HB 677** addressed concussion management, which would require baseline cognitive-linguistic assessment at pre-season for school-aged athletes. SLPs were included as healthcare providers in the language of this bill, allowing for participation on the concussion management team. This bill passed through the House but never made it out of the Senate Education Committee, where it died when the regular session ended.



• **HB 2038** also addressed concussion management but did not include the baseline assessment language. Although not specifically named, the language as written can accommodate for the participation of speech-language pathologists as licensed healthcare providers. This bill passed both chambers and was sent on to the Governor for his signature.

• **HB 270** dealt with Early Detection of Hearing Impairment (EDHI). TSHA contributed to formulation of language in the bill that made it acceptable to all stakeholders, but after passing through

the Senate and out of the House Public Health committee, it was not placed on the agenda for full House consideration and died when the regular session ended.

• **HB 2946** addressed insurance reimbursement for speech-language pathology services. **Rep. Garnet Coleman** introduced the bill again this session, and because of the fiscal implications, it languished in committee without receiving a hearing and died with the close of the regular session.

The TSHA Legislative Team monitored a number of other bills dealing with public school employees, special education, Medicaid, higher education funding, insurance reimbursement for services for individuals with autism, dyslexia, newborn hearing screenings, and changes to the Texas Retirement System.



In an effort to keep members involved and aware of the events in Austin, the Legislative Team produced a weekly online news update, *Capitol Watch*, authored by **Larry Higdon** and **Mark Hanna**. This newsletter was posted on the website, sent to all members via email, and linked on Facebook and Twitter. Members were provided with specific information about relevant bills and committee actions and also received thoughtful analysis of bigger picture issues such as the budget and redistricting and how these could potentially impact speech-language pathologists and audiologists across the state.

Several other initiatives on the Social and Governmental policy agenda also were accomplished. These included a continuation of town hall meetings across the state hosted by the Texas Regional Association Coalition (TRAC) in Dallas, South East Texas Speech and Hearing Association (SETSHA) in Beaumont, San Antonio Speech-Language-Hearing Association (SASHLA), Speech Pathologists' Association Near Dallas (SPAND) in McKinney, Wichita Falls Area Speech and Hearing Association (WFASHA) in Wichita Falls, and El Paso Speech and Hearing Association (EPSHA) in El Paso. As directed by the strategic plan, prior to the Sunset Commission hearing in November, TSHA hosted a gathering of leaders from related professional associations with similar legislative agendas. The goal of this event was open-door coalition-building, seeking support for our Sunset Review, and offering support for their legislative agendas. This meeting was attended by representatives from the Texas Physical Therapy Association, the Texas Classroom Teachers Association, and the Texas Nurses Association, among others. The outcome was very positive and served to build and strengthen relationships at the legislative level.

Prior to the session in January, TSHA participated in a Legislative Summit hosted by the Texas Society of Allied Health Professions (TSAHP). This association represents more than 50 medical professions and the educational institutions through which they are trained. Accordingly, there were legislative agenda items that were of concern to the group at large. Bess served as panelist in a discussion of legislative items that had the potential to affect professions across the board. This was another excellent opportunity for coalition-building, and TSHA will be an ongoing participant in this organization.

In an effort to build grassroots involvement, the Voter Voice program was implemented again during the 2011 legislative session. Several calls for action were sent at critical points of legislative activity, and although the overall response rate was lower than targeted, the total number of TSHA members who responded by sending messages to their elected officials was double that from the



2009 session.

## COUNCILOR/VICE PRESIDENT-ELECT FOR SOCIAL AND GOVERNMENTAL POLICY Bobbie Kay Turkett

Bobbie Kay served an indispensable role this year, participating in all the Executive Board meetings, attending coalition-building gatherings, observing legislative hearings, and being a resource of constant encouragement for all the committees and task forces under the Vice Presidency for Social and Governmental Policy. She also participated in presentations at the TSHA Convention and held a town hall legislative review meeting in Austin at the end of the session. She has worked closely with the other members of the legisla-

tive team and is well-prepared to assume the leadership role as VP.

## LEGISLATIVE TEAM

#### Larry Higdon, Director of Governmental Relations Legislative and Legal Counsel, Mark Hanna

Larry and Mark continued to lead TSHA's legislative advocacy work with expertise and diplomacy. They presented a positive and professional face to the elected officials in the Capitol, built relationships with key staffers, shepherded the Sunset Review legislation, coached the TSHA leadership on testimony, and carefully monitored more than 60 other bills related to the disciplines of speechlanguage pathology and audiology during the session. This team also produced the weekly legislative newsletter Capitol Watch to keep members updated on activities in Austin during the session.

## SUNSET REVIEW TASK FORCE

#### **Chaired by Sherry Sancibrian**

Under Sherry's experienced guidance, an advisory group of seasoned TSHA leaders representing all parts of the state and all work settings established priorities for the Sunset Review agenda. Based on the input from this group, specific language was developed that addressed necessary changes in the licensure law. Sherry provided expert testimony at House and Senate hearings, and she was instrumental in the success of this legislative effort.

## POLITICAL ACTION COMMITTEE (PAC)

#### **Chaired by Larry Barnes**

Under Larry's direction, the PAC went through significant reorganization and a rewrite of the bylaws this year with a new configuration that is more representative of the membership statewide. This was a busy year for the PAC as this was an election cycle, and new fundraising strategies were implemented. Convention was a particularly busy time as recognition lapel pins were produced denoting levels of support for PAC membership. These lapel pins served as significant incentives for increased donations. The massage chairs were a popular destination for convention delegates as was the silent auction. In addition, a PAC recognition breakfast reception was held at the convention to honor PAC donors.



## CAPITOL VISIT

#### **Chaired by Marcus Neal**

On April 5, about 20 TSHA members from across the state gathered in Austin for a training session and then paid a visit to their elected officials. Members received packets of information, maps, and talking points to share with senators, representatives, and their staff members. The feedback from participants, as well as most of the legislators, was very positive. For some of the participants, it was their first visit to the Capitol for this type of interaction, but it certainly won't be the last. Thanks to Marcus and State Office staff for coordinating a memorable event!

#### **GRASSROOTS TASK FORCE**

#### **Co-chaired by Lori Colletti and Allie Atkinson**

Lori and Allie brought great enthusiasm and organization to their task of fostering member involvement in the Social and Governmental Policy agenda. At the annual convention, members who visited the grassroots booth were given the opportunity to become registered voters, to sign up for Voter Voice, and to learn more about TSHA's legislative agenda.

## LEGISLATIVE ACTIVE STUDENTS TASK FORCE

#### Co-chaired by Kevin Van den Bogaard and Alyssa Valles

This task force is charged with the responsibility of identifying a key student contact at each university program in Texas. Kevin and Alyssa made contact with the NSSLHA chapters at each university and, at



the convention, hosted the first-ever roundtable discussion for students regarding the legislative issues. Feedback was very positive as students recognized the importance of legislation on their future careers, particularly with bills such as student loan repayment.

## CONSUMER ADVOCACY NETWORK

#### **Chaired by Karin De la Fuente**

Karin worked closely with Mark Hanna and developed specific forms to be used for recruiting consumer participants for legislative advocacy work. The protocol for consumer involvement is in the final stages of development as is a database for managing the lists of contact information.

## REGIONAL ASSOCIATION TASK FORCE Chaired by Adina Evans

Contact was made with regional associations to offer free continuing education workshops on the legislative process and TSHA's political agenda. As noted, seven meetings were held across the state, sharing information with about 300 speech-language pathologists and audiologists.

Special thanks are extended to **Don Canada, Jennifer Stamps, Shana Spring, Melinda Daise**, and **Tammy Ybarra** of the TSHA State Office in Austin for their constant support, encouraging words, and unfailingly positive perspective on the work that needed to be done.

The successes in Social and Governmental Policy this year have been substantial, but rather than resting on our laurels, the TSHA Legislative Team is already beginning discussions and preparation for the next leg-

islative agenda in 2013 to address issues that were left unfinished in 2011. Notably, the next Sunset Review of our licensure law has already been projected to occur again in only six more years in 2017. TSHA's work is not yet done.
